PEEWEE CLASSES:

- Walk/trot only, for riders 10 & under, or EWD. Rider may enter three-gaited classes, but will not be eligible for PeeWee classes the following year.

"OPEN" LEAD LINE CLASS:

- Only "Open" division; no NQPA Lead Line class at this show. For riders 8 & younger. May not enter any other riding class at this show.

WALK-TROT TRAIL:

- A rider/horse combination may not enter both regular and walk-trot trail.

TO ENTER ANY NQPA CLASS

- Pony must be registered with the NQPA, and both the rider and owner must be members of the NQPA. To qualify for NQPA registration, ponies must be 46-58" and can be measured & registered at the show.

***CLASSES 29 THRU 46 WILL RUN CONCURRENTLY UNLESS THERE ARE MORE THAN 5 OPEN ENTRIES IN THE CLASS...EXCLUDES \$100 CLASSES May Enter Both Divisions OPEN & NQPA**

•Youth pertains to exhibitors 18 yrs. or under as of 1/1/23 [born in 2005 or later]. •Showmanship may be shown in English, Western or Ranch tack/attire. •Classes 35 & 50 only acquire SOQPA year-ends points, but not any NQPA points.

CLASS FEES: Exhibition Runs - \$5.00 Regular Classes \$6.00 - Ribbons \$100.00 Classes - \$10.00

[\$100 classes having no more than 12 entries will be paid back at 80% of total entry fees received for that class.]

Grounds/Administrative Fee - \$6.00 per horse [except Henderson's, \$12 per horse].

ALL DAY FEE FOR **SOQPA MEMBERS**: \$60 Per Rider/Equine team, for regular NQPA and Open classes only; does not include \$100 classes, exhibition classes, nor grounds/administrative fees.

No refunds on classes scratched by exhibitor. Only classes cancelled by SOQPA will be refunded.
