If you preregister, whether you pay online or wait to pay the day of the show, *you will be able to amend/change/ cancel entries before your first class and your fees will be adjusted accordingly*.

The back number will follow the horse. Thus, a separate entry form is needed for each horse. If there are multiple riders, we need an entry form for each rider. To use this form, simply click next to the classes you are entering and a checkmark should appear. **If pre-entering, download this fillable form, make your entries, then "SAVE" your changes and email the form to: s.o.quarterpony@gmail.com.** After we receive your entries, we will calculate your total fees and send you an invoice.
